“The issue with most fraud detection solutions we considered was that they only spotted fraudulent activity once it was complete,” said Marsha Majors, President and CEO of U.S. Eagle Federal Credit Union. “The fact that we can save a lot of the time and trouble of recovering from a cyber-attack is not only a game-changer for us, but for our members, too.”

What sets the solution apart is its ability to prevent fraud before it happens. Most other products only alert account holders and institutions to fraudulent activity after it’s already happened, leaving a mess to clean up after the fraudster is long gone. Financial institutions often must work to reimburse any funds that were stolen in the attack and account holders are left feeling violated and mistrustful. By stopping fraud before it happens, Real-Time Fraud Control saves financial institutions from the time, cost, and reputational damage that comes with a successful attack.
