## NASCUS Welcomes New Board and Advisory Council Members

**ARLINGTON, VIRGINIA** – During the 2022 State System Summit (S3) Annual Meeting, the National Association of State Credit Union Supervisors (NASCUS) announced new officers as well as newly elected and appointed directors to the NASCUS Regulator Board and Credit Union Advisory Council.
