If you've watched the hit Apple TV series, Ted Lasso, you may have seen the poster of John Wooden's Pyramid of Success hanging in Ted's office. John Wooden is the legendary basketball coach who won 10 National Championships while coaching at UCLA and he is one of only five people inducted into the Basketball Hall of Fame as a player and a coach. Interestingly, Coach Wooden never spent his time talking to his player about winning; instead, he focused his players on working to become better people. Coach Wooden used his Pyramid of Success as the linchpin for these conversations with players. John Wooden spent 14 years identifying 25 behaviors he believed were necessary to achieve his idea of success. This search culminated in a simple but profound diagram Wooden called the Pyramid of Success, which he completed in 1948. Almost eight decades later these foundational behaviors have weathered the test of time. This webinar has nothing to do with basketball and everything to do with the characteristics that, when applied, lead to great success for you and your team.
