[NASCUS Announces 2024 Board and Advisory Council Election Results](#)

ARLINGTON, VIRGINIA — In August, the National Association of State Credit Union Supervisors (NASCUS) conducted its annual elections for its Regulator Board and Credit Union Advisory Council.

Members of the NASCUS Regulator Board are elected by regulator members of NASCUS, comprised of all state credit union regulatory agencies across the nation. Two Board seats were up for election this year. Patricia Perkins (Idaho Department of Finance) was elected to a first term on the Board while Denice Schultheiss (Michigan Department of Insurance and Financial Services) was re-elected to serve another three-year term. The 2024 – 2025 NASCUS Board will be seated during the Annual Meeting held at next month's [State System Summit](#) (S3) in Colorado Springs.

Members of the NASCUS Credit Union Advisory Council are elected by credit union members from across the nation. The Council advises the Regulator Board on issues of importance to credit unions. Three Council seats were up for election this year. Amy Nelson (Point West Credit Union, Oregon), Catherine Tierney (Community First Credit Union, Wisconsin), and Mike Williams (Colorado Credit Union, Colorado) were re-elected to serve three-year terms. Their new terms will also commence during this year's Annual Meeting.
